

Privacy Statement

Brewster Bail Bonding is committed to protecting your privacy and developing technology that gives you the most powerful and safe online experience. This Statement of Privacy applies to the Brewster Bail Bonding Web site and governs data collection and usage. By using the Brewster Bail Bonding website, you consent to the data practices described in this statement.

Collection of your Personal Information

Brewster Bail Bonding collects personally identifiable information, such as your e-mail address, name, home or work address or telephone number. Brewster Bail Bonding also collects anonymous demographic information, which is not unique to you, such as your ZIP code, age, gender, preferences, interests and favorites.

There is also information about your computer hardware and software that is automatically collected by Brewster Bail Bonding. This information can include: your IP address, browser type, domain names, access times and referring Web site addresses. This information is used by Brewster Bail Bonding for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Brewster Bail Bonding Web site.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through Brewster Bail Bonding public message boards, this information may be collected and used by others. Note: Brewster Bail Bonding does not read any of your private online communications.

Use of your Personal Information

Brewster Bail Bonding collects and uses your personal information to operate the Brewster Bail Bonding Web site and deliver the services you have requested. Brewster Bail Bonding also uses your personally identifiable information to inform you of other products or services available from Brewster Bail Bonding and its affiliates. Brewster Bail Bonding may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

Brewster Bail Bonding does not sell, rent or lease its customer lists to third parties. Brewster Bail Bonding may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. In addition, Brewster Bail Bonding may share data with trusted partners to help us perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Brewster Bail Bonding, and they are required to maintain the confidentiality of your information.

Brewster Bail Bonding does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent.

Brewster Bail Bonding keeps track of the Web sites and pages our customers visit within Brewster Bail Bonding, in order to determine what Brewster Bail Bonding services are the most popular. This data is used to deliver customized content and advertising within Brewster Bail Bonding to customers whose behavior indicates that they are interested in a particular subject area.

Brewster Bail Bonding Web sites will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Brewster Bail Bonding or the site; (b) protect and defend the rights or property of Brewster Bail Bonding; and, (c) act under exigent circumstances to protect the personal safety of users of Brewster Bail Bonding, or the public.

Use of Cookies

The Brewster Bail Bonding Web site use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a Web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.
